3. All expenses in this connection will be borne by the National Agricultural Technology Program-Phase II (NATP-2)-BARC
4. The incumbent will submit a progress report of the research work to the Director General of the Institute at six months interval;
5. The incumbent will have to submit a report of his PhD work within 7 (seven) working days of his return in the prescribed format of the Ministry of Agriculture or as required by the scholarship authority.
6. The incumbent will have to abide by the rules of higher education and other terms and conditions set by the Government currently or in future.
